- Quantity
- Details of all specifications and processes applied.
- e) Any product found not to comply with the purchase order or the conditions above will be subject of a rejection report and your account will be debited for the cost of the components / parts / materials.
- f) If the scrap caused by processing errors exceed 5% of any individual batch / order qty then clause 'e' would apply, plus the replacement casting value would be debited to you for any excess to the agreed percentage. (subcontractor processing free issue components only)
- g) All scrap arising from the processing of this order will remain the property of Tritech Group and will be returned with the whole consignment. (subcontractor processing free issue components only)
- h) Tritech Group representatives and representatives of any other organisation on the authority of Tritech Group shall be allowed to visit the supplier's premises and shall be afforded all necessary facilities at any reasonable time to check the progress or quality of the work on the supplies.
